## Riksbyggen chooses Assemblin Charge as framework agreement supplier for electric car charging

Assemblin Charge has signed a nationwide agreement with Riksbyggen for the operation and installation of charging stations as well as for billing management for electric car charging. The agreement covers a three-year period, with the possibility of a one-year extension. To date, about 660 charging points distributed between 65 facilities have been connected to Assemblin Charge and efforts continue to assist more housing associations within Riksbyggen.

Assemblin Charge is now Riksbyggen's official partner for the operation of existing charging stations, billing for charging services, as well as for the installation and operation of new charging stations in Riksbyggen's property portfolio.
