Assemblin VS strengthens RCE position in Stockholm through three acquisitions

Assemblin has acquired sister companies Botkyrka VVS & Fastighetsservice AB, ELIN i Stockholm AB and SDC Stockholm Design & Construction AB with annual sales of approximately SEK 125 million and 42 employees in total. The acquisitions strengthen Assemblin VS's operations in Stockholm within RCE (repairs, conversion, extension).

The three companies have been acquired from the majority owner Bröderna Brolins Fastigheter AB and are specialised within RCE, often on common projects and service assignments. The acquired operations were part of the Comfort chain, where they previously have been awarded "Årets Service- och Entreprenadföretag" (Service and Contracting Company of the Year).

"We are delighted with these acquisitions and the chance to welcome new employees and customers to Assemblin. These are high-quality companies with long-standing customer relationships and a good market reputation, which fit well with Assemblin's profile. We particularly value their specialisation in RCE assignments, making them a welcome addition to our Stockholm operations," says Andreas Aristiadis, President and Business Area Manager for Assemblin VS.

The operations are concentrated in the Botkyrka area of southern Stockholm but have the capacity to grow.

"We are proud of the operations of Botkyrka VVS & Fastighetsservice; ELIN i Stockholm and SDC Stockholm Design & Construction, but believe that the companies can develop better with another kind of owner moving forward. During the sales process, we concluded that we have a shared understanding regarding quality, culture and customer relations, which was crucial for closing the transaction," say Stefan and Tommy Brolin of Bröderna Brolins Fastigheter AB.
