Assemblin Electrical has signed an agreement to acquire APQ Power AB with eight employees and annual sales of about SEK 91 million. APQ Power primarily offers services in power and high-voltage – a strategic growth area for Assemblin.

APQ Power AB is part of the ApQ EI Group. ApQ Power specialises in power and high-voltage and is based in southern Sweden. Customers include public sector operators, industrial companies, as well as construction and installation companies. The acquisition entails the unit being placed within Assemblin Electrical's Region South as a new branch office, Kraft Malmö, which will work alongside Assemblin's other high-voltage operations around Sweden.

"We are very pleased to be able to strengthen our position in southern Sweden, particularly in power and high-voltage, which is one of our strategic growth areas. We are familiar with the operations of ApQ Power from previous collaborations at the new hospital in Malmö and are impressed with the unit's expertise," says **Fredrik Allthin**, EVP and Head of Division, Assemblin Caverion Group in Sweden.

The transaction will be closed in September.
